

**AGREEMENT**

I understand that I have been appointed under the Delhi Police Act, 1978 and the purport and provisions of the Act now in force, by which my discipline and conduct is to be governed have been explained to me. I agree to serve faithfully under the provisions of the said Act, 1978 and such acts and Rules applicable to Delhi Police Administration, Government of India from time to time and to obey all lawful orders issued by superior Officer. I, hereby, further bind myself to the following agreement as required under Rule 5 (F) of the Delhi Police (Appointment & Recruitment) Rule-1980.

Whereas the training of each individual Officer in the Police to do the work allotted to him/her is of the Highest importance and whereas Chapter XIX of the Punjab Police Rules 1934 as applicable to the Union Territory of Delhi (hereinafter referred to as "the said Rules") provided inter alia for such training. And, whereas, it is concerned necessary in the Public interest that the Police Officer trained at the expense of the Government during his/her service period should serve the Government for period of at-least 'five years' from the date of appointment.

Now, therefore, this agreement witness as follows :-

1. In the event of selection, the Police Officers for the purpose of any training or course irrespective of the fact whether a specific provision is made or not made for such a course or training Chapter XIX of PPR (hereinafter, referred to as such training) at the expense of the Government and treating the period spent on such training as the period spent on duty, the Police Officer hereby undertakes that he/she shall be bound to undergo and complete such training if so required by the Government and that after completion of each such training he/she shall serve the Government for a period of at-least five years from the date of appointment in Delhi Police (if required to do so) failing which he/she shall not withstanding that if he/she resigns from office with permission of the Dy. Commissioner of Police within the meaning at Delhi Police Act, 1978 and not withstanding any thing contained in the Central Civil Services



(Temporary Service) Rule 1965, refund on, demand to the Government. The whole amount inclusive salary, stipend/tuition fee, cost of extra articles of uniform issued and capitation charges spent in connection with such training irrespective of the fact whether it was completed or not, will be refunded. The decision of the Commissioner of Police, Delhi regarding the quantum of such amount shall be final and binding the Police Officer and surety.

2. In the event of any such training being imparted to the Police Officer at the expense of the Govt. and the Police Officers fails to pay the amount referred to in clause, I, the surety, hereby guarantee the repayment of the said amount, in accordance with the covenant herein contained.
3. All the amount due from the Police Officer and/or the surety under the terms of this agreement shall be recoverable as arrears of land revenue.
